### **COSTS FOR THE 2021 SEASON:**

The registration fee will be \$75.00 per player, with a maximum of \$180.00 per immediate family (children residing at the same address). Payment in full is due at the time of registration. If a player registers after February 15th, there will be a \$20.00 LATE FEE per player added to the \$75.00 per player registration fee. There is a returned check fee of \$30.

Unless additional players are needed to fill rosters in a certain age group, no late registrations will be accepted after **March 1st**, as the team will be formed. Except in extraordinary circumstances, we cannot make exceptions to this rule, as we have to decide how many teams we will field in each age group and how many players will be on each team prior to the draft. Exception requests for late registrations will not be accepted after 3/27/21, as that is the date by which we have to submit uniform orders to our uniform supplier and final rosters to the County Board.

Registration fees cover costs including but not limited to the following: team uniforms (shirts and hats), coaches' shirts and hats, equipment, umpires, field preparation costs, game balls, score books, copy supplies, and tournament fees.

Team shirts and hats will be provided. Each player will provide his or her own baseball pants/softball shorts, socks, etc.

#### **SCHEDULE FOR THE 2021 SEASON:**

Registration will take place in early February, rosters will be completed in mid-March, and practices will commence ON April 1st. Regular season games will commence in May and June, and post-season tournaments concludes by July 1st.
